e) Play Area Monthly Inspection

<u>DW</u> will carry out an assessment of repairs required and share findings. Feedback awaited from David Bracey on suitable materials to provide a hardstanding area under basketball net. Quotes for new signage will be shared at next meeting

f) Garrick Field Monthly Inspection

The hazels in the Jubilee wood will need coppicing in November. All bins on the Garrick Field will now be emptied by SNDC.

g) Village Pond Inspection

Replacement saplings have been planted to replace those that failed. Wildflower seed will be sown on the soil banking adjacent the new footpath as a temporary measure until the next stage of the pond project is underway.

12. Parish Projects

Pond

JMcN met with a local contractor to discuss next steps to improve access to the pond now that the footpath works have been completed. A technical design will be drawn up for discussion with Councillors. It is hoped that work can start late summer.
